1. Welcome & Apologies	The Chairman welcomed everyone to the meeting. There were no apologies forthcoming.
2. Minutes of the meeting held on 13 September 2016	The minutes of the previous meeting were approved. There were no new conflicts of interest.
3. SPAR & ICT	<p>NJ welcomed Tania Stitch, Sue Waterhouse and Rita Thakaria to the meeting.</p> <p>TS advised that Thurrock's new Single Point of Access (SPAR) is a joint appointment between NELFT, Thurrock Council and SEPT. The new service would focus on a single access point providing access to professional advice and information and care co-ordination; delivery date is targeted for February 2017. TS said the new name for the service is called 'Thurrock First'.</p> <p>TS advised that the new service will be an integrated service ran between the three services which would be one single access point contactable by email, app, or the phone. There would be access to professional advice and care co-ordination across the disciplines under one service; the service would be open 7 days a week.</p> <p>RT presented a slideshow on 'Integrated Community Older Adults Health and Wellbeing Service'. RT advised that the new model had been possible from recent investment made which is part of a long term condition service, in improving the wellbeing of older adults.</p> <p>The service would be a single access point which will be supported by Community Geriatrician's which would identify older adults and supporting them or signing them back in the community.</p> <p>RT advised on the various avenues of support i.e. Locality MDT's, Clinics (4 per week), Care Home support and Domiciliary Visits in the community.</p> <p>RT said they are already working with a number of practices to identify patients with frailty and will be phasing in support to other practices. The group looked at the Falls Audit slide whose aim is to reduce the number of falls, which often led to fractures.</p> <p>TS advised that they were waiting to hear from Success Regime whether someone from housing will be in the pod. They will also be linking in with 'One Response'.</p>
4. Success Regime	No report.
5. IAPT - Recovery College	<p>RM gave an update on IAPT and Thurrock Recovery College and gave special mention and thanks to Jane Itantaga for her continuing good work.</p> <p>RM advised that IAPT is an evidence based treatment programme and now working in Thurrock; providers are Inclusion in Thurrock, which has transferred from being the worst to the best performing for IAPT provision. Key highlights have been to build links with other providers.</p> <p>RM introduced Mark Frost, Clinical Lead for Inclusion Thurrock who gave background to their work. RM advised that since its inception on 1st April, 1,500 people have used the service with 5,500 attended appointments from 1st April. The waiting time for an assessment is on average 4 days, but most people are assessed by the following day. The waiting list for counselling for depression is approx. 8/9 days.</p>

MF advised that they will be looking at providing specific groups for older adults with 4-6 in a group. Discussion followed on waiting time, and it was hoped to have more evening appointments made available, as more funding has been granted for more clinicians.

Renée Hepker introduced herself as the Recovery College Lead and also a mental health occupational therapist. RH gave background to her work and the new service, which was open to anyone over the age of 18. RH said she was in conversation with SEPT for people coming out of secondary care and in talks with Thurrock Council and the CCG. It was hoped to have evening appointments and evening courses and any volunteers would be welcome.

MF said the College will also help people that are not directly a mental health patient. They may be a carer or family member. It was hoped to educate people and learn through people that have lived through mental care issues. MF confirmed that courses were free of charge in the community across the Borough.

A question arose regarding patients who want to commit suicide. MF/RH confirmed that in an emergency they would always refer to A&E. If not, than people are advised to see their GP.

RH confirmed there was no limit on how many sessions people can attend. Each person would be reviewed after their course. Anyone who shows interest in attending a course would be met face to face before attending the course.

MF advised that the Recovery College page can be accessed through the IAPT page on the web.

6. Practice Concerns - New template Letters

LG raised the subject of the recent launch of GPC template letters for GP practices to push back on instances where hospitals breach new requirements introduced to the hospital standard contract with effect from the April. The new requirements cover a variety of topics ranging from discharge policies, clinic letters, medication on discharge, results etc. It was hoped that the new template letters will empower practices to demand that hospitals honour these changes and thereby reduce the burden of bureaucratic burden to GPs.

GP's unanimously agreed that a letter from Thurrock CCG should be sent on behalf of CEG in support of above.

It was hoped that Kate Woolterton, BTUH will be in attendance at the next CEG.

7. AOB

RM gave a brief update on Shared Care Protocol including the benefits to GPs and the CCG.

RM advised that he would continue to update the Group.
